Income Tax Rates and Deductions

Tax Rates

Ordinary Income Tax Rates	10%, 15%, 25%, 28%, 33%, 35%
Capital Gains and Dividend Tax Rates	0% (10%/15% tax brackets), 15% (other tax brackets)
Alternative Minimum Tax Exemption	\$33,750 single/\$45,000 married (without Congressional action)

Personal Exemption Deduction (\$3,800)

Joint Returns and Surviving Spouses	\$11,900
Heads of Household	\$8,700
Single Taxpayers	\$5,950
Married Filing Separately	\$5,950
Dependent	\$950 or \$300 plus earned income, if greater
Age 65 and Older or Blind - Single or Head of Household	Additional \$1,450 each
Age 65 and Older or Blind - All Others	Additional \$1,150 each

"Kiddie" Tax (children under age 19 and dependent full-time students under age 24)

Amount	\$1,900
Alternative Minimum Tax Exemption	\$6,950 plus child's earned income

Hope Scholarship Credit (American Opportunity Tax Credit):
